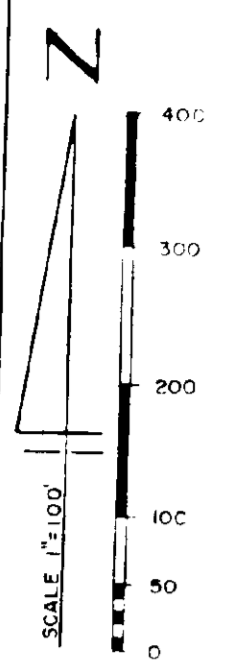


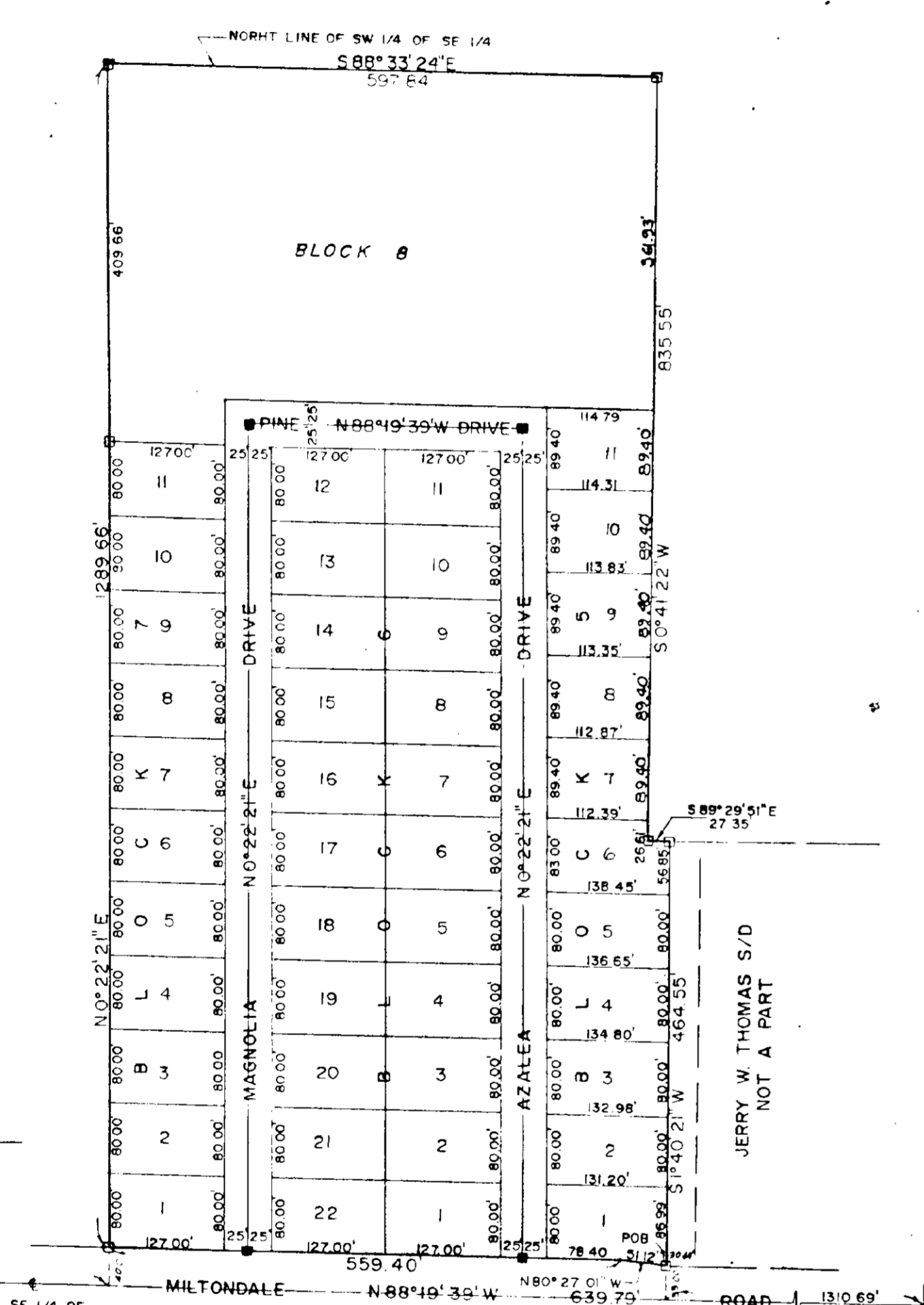

DESCRIPTION:

COMMENCE AT THE SOUTHEAST CORNER OF SECTION 30 TOWNSHIP 2-SOUTH, RANGE 22-EAST AND RUN THENCE N88°19'39"W, ALONG THE CENTERLINE OF MILTONDALE ROAD, 1310.69 FEET, THENCE N1°40'21"E, 33.00 FEET, TO THE NORTH RIGHT-OF-WAY LINE OF SAID MILTONDALE ROAD, AND TO THE POINT OF BEGINNING, AND RUN THENCE N80°27'01"W ALONG SAID NORTH RIGHT-OF-WAY LINE, 51.12 FEET, THENCE N88°19'39"W, ALONG SAID NORTH RIGHT-OF-WAY LINE, 559.40 FEET, THENCE N0°22'21"E, 1289.66 FEET, TO THE NORTH LINE OF THE SW 1/4 OF THE SE 1/4, THENCE S88°33'24"E, ALONG SAID NORTH LINE 597.84 FEET, THENCE S0°41'22"W, 835.55 FEET, THENCE S89°29'51"E, 27.35 FEET TO THE NORTHWEST CORNER OF JERRY W. THOMAS SUBDIVISION, THENCE S1°40'21"W, ALONG THE WEST LINE OF JERRY W. THOMAS SUBDIVISION 464.55 FEET TO THE POINT OF BEGINNING.
