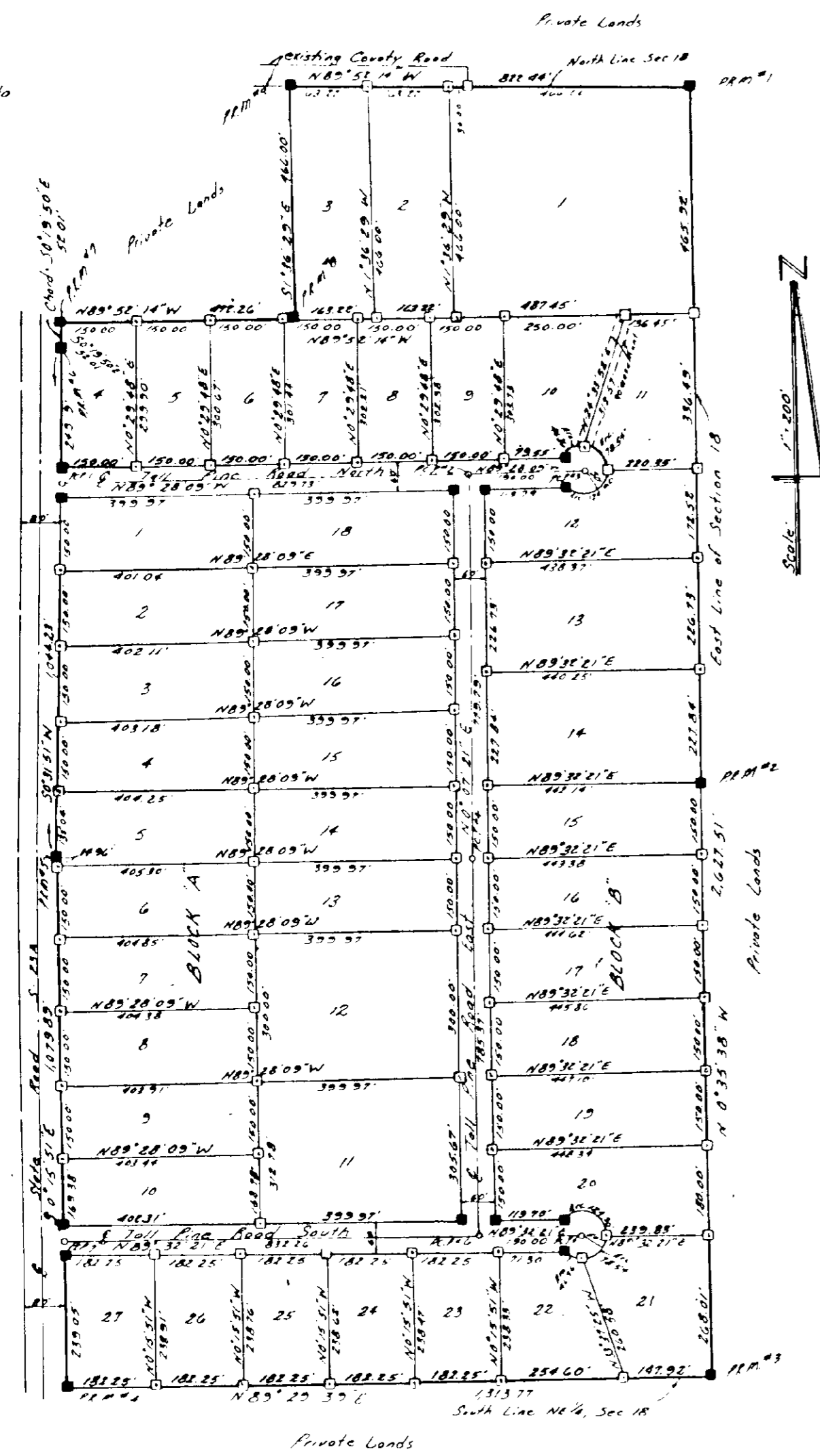


MACCLENNY WOODS

DESCRIPTION:

COMMENCE AT THE NORTHEAST CORNER OF SECTION 18, TOWNSHIP 2 SOUTH, RANGE 22 EAST, THENCE RUN N 89° 52' 14" W ALONG THE NORTH LINE OF SAID SECTION, 822.44 FEET, THENCE S 1° 36' 29" E, 466.00 FEET, THENCE N 89° 52' 14" W, 472.26 FEET TO THE EAST RIGHT-OF-WAY LINE OF STATE ROAD NO. 5-23A AND A POINT ON A CURVE, THENCE SOUTHERLY ALONG SAID EAST RIGHT-OF-WAY LINE ALONG A CHORD BEARING S 0° 19' 50" W, 52.01 FEET TO THE END OF SAID CURVE, THENCE S 0° 31' 51" W ALONG SAID EAST RIGHT-OF-WAY LINE, 1044.23 FEET, THENCE CONTINUE ALONG SAID EAST RIGHT-OF-WAY LINE S 0° 15' 51" E, 1079.89 FEET TO THE SOUTH LINE OF THE NORTHEAST 1/4 OF SAID SECTION, THENCE N 89° 29' 39" E, 1313.77 FEET TO THE EAST LINE OF SAID SECTION, THENCE N 0° 35' 38" W ALONG SAID EAST LINE, 2627.51 FEET TO THE POINT OF BEGINNING.
