DESCRIPTION: COMMENCE AT THE N.W. CORNER OF SAID SECTION 33 AND RUN EAST ALONG SECTION LINE, 491.4 FT. TO THE EAST LINE OF EAST BOULEVARD IN THE TOWN OF MACCLENNY, FLORIDA, FOR A POINT OF BEGINNING AND RUN THENCE N. 89° 43' E, ALONG SAID SECTION LINE, 1096.96 FT., THENCE S. 72° 24' E, 425 FT.; THENCE S. 79° 11' W, 334.3 FEET; THENCE S. 10° 24' E, 645 FT. TO THE RIGHT OF WAY LINE OF S.A.L. RR.; THENCE S. 79° 11' W, ALONG SAID RIGHT OF WAY, 675.37 FT. TO SAID EAST BOULEVARD; THENCE N. 10° 24' W, 1253.8 FT. TO POINT OF BEGINNING, EXCEPT RIGHT OF WAY FOR U.S. HIGHWAY NO. 90, 66 FT. IN WIDTH.
