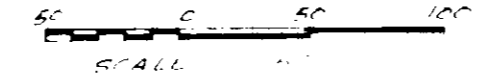


"CAMP OSCEOLA"

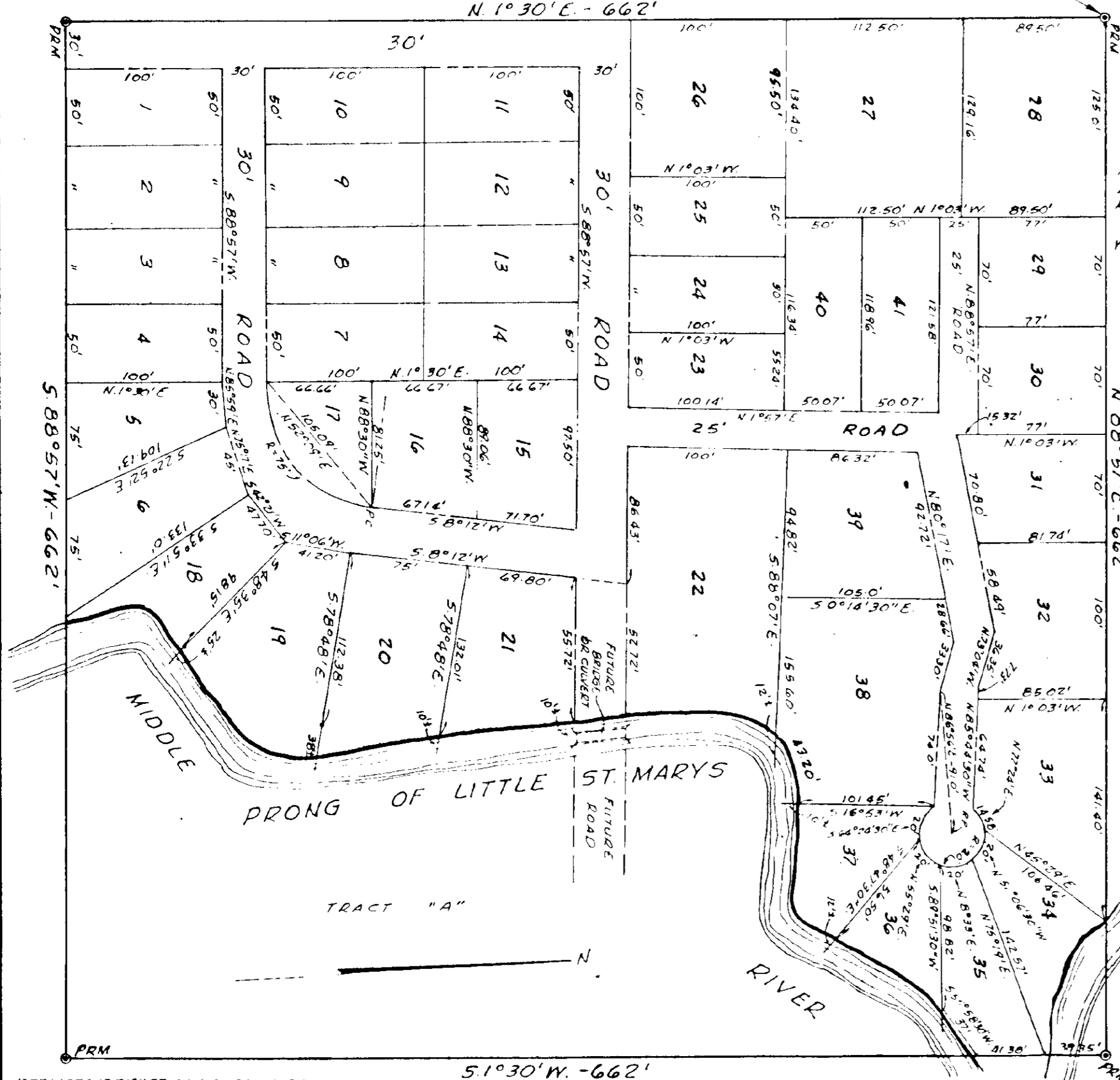
SURVEYOR'S CERTIFICATION
